All positions are open for any resident to run. Current open positions are Vice President (in charge of violations), a Maintenance Chair (landscaping and sprinklers), a House Chair (oversees clubhouse and surrounding area), and a Treasurer Receivables (keeps track of maintenance fees and late accounts, sends late notices). As always, some of our Board members are tired and would like to be replaced, even those still in their positions, but we need people to step up. As a board member, you make a commitment to follow through on your assigned duties and attend Mainlands 4 Board and Civic/Homeowner meetings. You will not always be appreciated and the pay is not very good, but you will play a BIG part in keeping our community looking good and running efficiently. And you will be a part of a great team of homeowners who are doing the same. (i.e. board members.)

The State requires a functioning board, as do our governing documents, or we will go into receivership. Please know that if we cannot get enough homeowners to volunteer as board members, the State of Florida will require us to hire a professional property management company to administer Mainlands 4 for us...It is the law! And we will be paying for theier services. This will increase our monthly maintenance fees substantially!

President's Report

This is our community and there is much to do. Board members need your help in following rules and regulations and volunteering for various committees.

Recently, we have had to turn over files to the attorney because of rules not being followed. This is a strain on the community as it costs us money each time that happens. In the long run, it costs you more money because that money comes from your maintenance fees. That increases everyone's fees. So we ask you, please follow the rules, pay your maintenance fees on time, and help.

The 2026 budget is being worked on and should be ready for the November meeting. There will be a slight increase to next years fees, but we are hoping to keep it as minimal as possible. We work hard to do as much as we can with as little as we can because we pay monthly fees as well.

The updated Reserve Study will be ready by the end of the month. This will let us know where we stand with savings toward major projects. This coming year we need to resurface the pool and put new windows in the clubhouse, not to mention many sprinkler repairs to wiring and pipes.

Which brings me to the issue of **tree planting.** Too many residents have planted trees near or too close to the sprinkler lines and boxes. This causes disruption and damage to the sprinkler system for many homes. Residents complain about not having sprinklers, but many are caused by the trees planted.

If you have planted a tree too close to the sprinkler lines, you will be responsible for the repair bill. Last month alone the repairs bills were over \$3000. That doesn't include regular lawn and sprinkler maintenance! Ask before you plant. Complete the Approval Form located on our website or at the clubhouse. As said, if you plant without approval it is a \$100 fine and you must remove the trees.
