


President's Report:

IMPORTANT CIVIC MEETING IN SEPTEMBER. WE NEED A QUORUM.

Welcome our new Vice President, Paul Moore

Paul has stepped forward and offered to fill the position of Vice President. We are grateful to him fordoing this. That means that Paul is now responsible for handling and investigating violations. Remember, even if a violation is reported, the Board determines the violation. ONLY the BOARD has the power to issue a violation of our Governing Documents and does so only after investigating first and finding if a violation exists. If we find there is no violation, nothing is done.

Reminder: \$25 fine imposed

As you were informed in April, the Board instituted a fine of \$25 for parking on the grass. You will receive one courtesy notice and then any subsequent violations will be fined \$25 per violation. This assessment will go against the homeowner, no matter who is parking illegally. It is the homeowner's responsibility to make sure any visitors or vendors park correctly.

Additional fine: Some homeowners have been starting or completing alterations to the exterior of their homes or lots without first obtaining Board approval, which is required by our Governing Documents. In order to enforce our Governing Documents and this provision, which is legally required. The Board adopted the following measure:

"Any variation to a house or its property that requires Board Approval according to our Governing Documents, must have written Board approval prior to the commencement of the work.

Starting June 1, 2022, anyone violating this procedure shall incur a \$25.00 fine per violation. Additionally, all work must cease and desist until approval is granted." We may discuss raising this to the Statute maximum of \$100.

As with any fine, the homeowner or occupant may appeal the fine. FL 720.305 states, in part:

"A fine or suspension levied by the board of administration may not be imposed unless the board first provides at least 14 days' notice to the parcel owner and, if applicable, any occupant, licensee, or invitee of the parcel owner, sought to be fined or suspended and an opportunity for a hearing before a committee of at least three members appointed by the board ... If the committee, by majority vote, does not approve a proposed fine or suspension, the proposed fine or suspension may not be imposed."

Therefore, any owner or occupant who receives notice of the fine will also receive notice of the hearing date. If they wish to attend the hearing, they may do so.

The remedy for this is easy, fill out an Application for Landscape or Home alterations and submit to the office for the Board to review. Wait for it to be returned before starting any work.

Civic Meetings

We have **reduced our Civic meetings** in order to increase participation. It was voted to reduce Civic meetings to six (6) times a year – January, March, September, October, November and December. November is our Annual Meeting where elections take place. December is the installation of new Officers and Directors.



In the event an important issue arises that the Members must vote on, we will schedule Special Meetings for that purpose.

We would encourage you to attend Board meetings as all are welcomed and encouraged to attend.

IMPORTANT VOTE IN SEPTEMBER

At the September meeting, if we have a quorum we will be voting on reducing the number of Board members. No Board should ever have an even number of members as this allows for a tie, which would be detrimental to the business of the Association. Therefore, the Bylaws committee is recommending reducing the number of Board members from 10 to 9. Now seems to be the time to do this as we will be preparing for elections.

The Bylaws committee wrestled with which position could be moved to a committee Chair position, continue its vital work and submit a report each month, similar to what Jim does now with the library. We went back and forth between the Social and Recreation Chair position and the Publicity Chair position. In the end, the Publicity Chair seemed the most logical to move into a Committee position. This person already has a committee of Block Captains for which they are responsible and they can easily report on the number of ads, distribution and needs each month. I want to say this is in NO WAY REFLECTIVE OF ANYONE WHO HAS HELD THAT POSITION (myself included). Terence has been doing a phenomenal job and we hope he desires to continue to do so. In the end, it is the community who decides, According to our Bylaws, the number of Board members can be changed by the Association Members at a meeting where a quorum has been established. Another reason we need you there!






