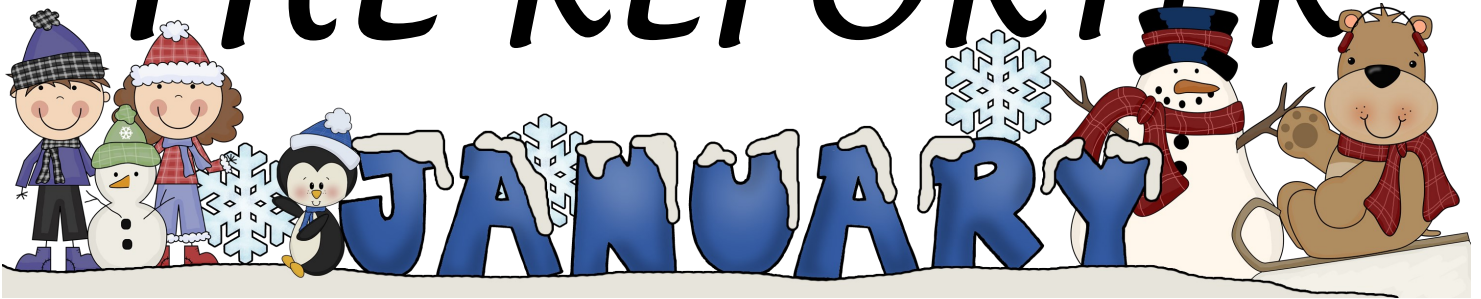

MAINTENANCE FEES ARE \$115 PER MONTH

*Be sure your payments reflect this new amount so late fees are not assessed and, if you make automatic payments, notify your bank of the change. Payments are due the 1st of each month and late after the 15th (with a late fee of \$25 added). It doesn't matter if you back date your check to the 15th, as some do, if it is not received **BY** the 15th it is late. Please save yourself some money and pay on time. Also, if you get a late notice, please see the bookkeeper on Saturdays to reconcile your records so that your account does not go to collections. If it goes to collections, it will automatically be an addition \$600 for legal fees. And if not paid the legal next step is a lien. No one wants that.*

Lastly, be sure to respond to any letters from the HOA received by mail or email. This helps resolve matters quickly and smoothly.

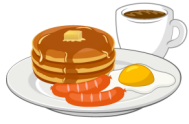
