

# **President's Report:**

Election time is here, both for our community in Mainlands Four and our larger community of citizenry. Some will be happy with the outcome, some will not. But in all things, we should keep the mindset that we can agree to disagree and still be friends. We can disagree without being disagreeable. That's what has been the cornerstone of this country for years.

I thought it may be a good time to review some accomplishments of the last year that we have done as a Board that have improved our community.

1. Bessemer and the Clubhouse! We are almost owners of our Clubhouse! I have worked diligently to get owners that owe or owed money to pay their share. Most have stepped up and done so, which has lower the amount owed in order to gain title. I have now negotiated with Paul Bessemer for a payoff balance and our attorney is drawing up the papers. Once we take ownership and assume the debt owed as assessments, owners who still have an outstanding balance will receive notice that they have 30 days to pay the balance or else we WILL lien their properties. So take heart, no one is getting away with not paying.

And once we take title, we will be having a party! So stay tuned for that notice!

- **2. Zoom** Our meetings are now held by Zoom as well as in person. Doing so allows anyone to attend and be counted toward the Quorum and voting (except elections) for Civic meetings. The meeting and Zoom details are always posted in the newsletter, so feel free to join us either in person or by Zoom.
- **3. New Attorneys** we had many complaints about our previous attorneys, how they were slow to move on things and charged us large amounts. I am happy to report our new (*Continued on page 2*)

attorneys, Straley and Otto, have been phenomenal. They are responsive to our needs, have been very proactive on cases, and aren't nickel and diming us for every email and call. I look forward to computing the difference in costs at the end of the year.

- **4. Civic Meetings** In an effort to be more conscious to the needs of the community, we have reduced the number of Civic meetings to 6 (Sept., Oct., Nov., Dec, Jan., Feb.) rather than 9. We are hoping this will encourage more attendance at the ones we do have. PLEASE BE SURE TO ATTEND THE NOVEMBER MEETING AS THE ELECTIONS TAKE PLACE AT THAT MEETING. While you can attend by Zoom, you cannot vote by Zoom for elections. Those must be paper ballots that will be explained in more detail later.
- **5. Communication** I have tried to improve communication in the community through email notifications. I have gotten feedback that most people appreciate being in the loop on many issues that occur between Newsletters. I want to expand this to include as many residents as possible, so if we do not have your email in our database or you haven't received the email updates and notifications, please send your email address to me at katejohnsonms4@gmail.com and I will make sure our database is updated.
- **6. Reserve Study and Account** We had a Reserve Study done that let us know where we stand with our equipment and building. It also showed us approximately how much money we should have in Reserves. To that end, the Budget was adjusted accordingly and the Treasurer of Accounts Payable has been transferring **\$1824** each month from the Trust Account to the Money Market (Reserve) Account. That has left us in good financial standing for repairs.
- 7. Irrigation and Landscaping We received so many complaints about our previous companies that residents said they stopped complaining as it did no good. Residents even stood up at every meeting to state how unhappy and dissatisfied they were. So the obvious choice was to look for new companies. The Board interviewed three companies and chose Nanak's. They asked us to give them 6 months to turn things around, which we have done. While some things have improved (we actually have a green back yard for the first time since moving here), there are still issues. I hear complaints and compliments. Some believe their lawns have never looked better, others that there is much to do, especially with irrigation. Contrary to rumors, I have been on top of Nanak's and they know they only have 30 more days to get it together or we will look for new companies. So while there has been progress, we are still working on what is best for the community. As an aside, I also



hear rumors that we pay them thousands... they actually are less expensive than our previous companies in total, but if they are not doing the job, we need to look elsewhere. And we will. We have checked out the companies Mainlands 1 &2 and Mainlands 3 use, and they are both much more expensive. But we will continue to do what is best for the community as a whole. - **8. Pro rata share** While not everyone would consider this an accomplishment, it is. According to our Bylaws, everyone shares equally in the cost of maintaining the Clubhouse, common area, equipment used, and services provided. This means that everyone's Maintenance fees should be the same. We brought everyone up to the highest monthly fee that was being paid at the time, which was \$75. To that end, some fees went up this year and others remained the same. This also put us in good financial standing to meet our yearly obligations.
- **9. Collections** Through diligence, the Treasurer of Accounts Receivable and bookkeeper have been able to reduce the monies owed to the Association and collect fees on arrears. This has put us on a much better financial footing.

I hope you will agree that these accomplishments (and many others) have been an asset to our community. If not, I'd love to hear from you. In the meantime, we will continue to do what we believe is best for the community to protect our individual and corporate interests in a fiduciary responsible manner.



#### **Election and Voting Procedures**



All members of the association are eligible to serve on the board of directors, and a member may nominate himself or herself as a candidate for the board at a meeting where the election is to be held, (FS 720.306, 9(a)).\* For voting, only one vote may be cast per lot or household.

If you cannot attend the November Civic Meeting, which we hope you can, you can still vote for the upcoming slate of Nominees. However, the Statute (FS 720.306) and our Documents (Bylaws Article IX and Declaration of Restrictions Article X) dictate how **absentee election ballots** are handled and submitted. Therefore, we will outline the proper procedures that we will be following. Note: If you do not handle it properly, your vote will not count. Please keep this in mind.

#### **Procedures for procuring a ballot:**

- 1. Ballots must be requested from the Secretary (Sandy Sanders). Any copies not obtained through the Secretary will not be counted.
- 2. Once completed, the ballot is put inside a plain white envelope and sealed. \*\*
- 3. That plain white envelope is put inside another envelope. That envelope is sealed and the person casting the ballot must sign their name and address over the seal. \*\*
- 4. The sealed and signed envelope is handed or mailed to the Secretary in person at least one day prior to the elections (November 15th). No one should be collecting ballots for others. \*\*\*
- 5. Once received, the Secretary will verify that the ballot is authentic and was requested and obtained through the Secretary by checking her list of requested ballots.
- 6. At the Civic Election Meeting, the Secretary will check the received ballots against the attendance records to ensure that only one vote per lot will be cast. (F.S. 720.306, 8(b))
- 7. The outside envelope will be removed and kept separately before the ballot is turned in to the Nominations Committee at the Civic Meeting so that all ballots remain confidential.

\*Keep in mind FS 720.306, 9, (b) also states that "An association may suspend the voting rights of a parcel or member for the nonpayment of any fee, fine, or other monetary obligation due to the association that is more than 90 days delinquent" and that if you are delinquent in any financial obligation, you cannot run for office.

\*\*720.306, 8(b) such ballots must be placed in an inner envelope with no identifying markings and mailed or delivered to the association in an outer envelope bearing identifying information reflecting the name of the member, the lot or parcel for which the vote is being cast, and the signature of the lot or parcel owner casting that ballot."

\*\*\*Declaration of Restrictions, Article X- "Voting privileges of members shall be limited to one vote per household and may be cast... by absentee ballot, if requested, and obtained from, and returned to, the Secretary of the Association at least one day prior to the voting date. Absentee ballots that have been timely submitted to the Association shall be considered the presence of the voting interest at a Membership meeting for the purpose of quorum."



Social (to help plan and carry out functions)


Fining and Suspension (to hear appeals to fines, meets monthly)

#### Bingo!

Did you know that there is a State Statute that regulates Bingo? I didn't! But there is. I am sure no one else knew either! I am all for Bingo starting, we just have to do it legally. Once you know something exists, you can't look away. Not only that, it is criminal to do so. First offense is a misdemeanor. Second offense is a felony. So here is the statute (relevant sections):



849.0931 Bingo authorized; conditions for conduct; permitted uses of proceeds; limitations.—

- (4) The right of a... homeowners' association... to conduct bingo is conditioned upon the return of the net proceeds from such games to players in the form of prizes after having deducted the actual business expenses for such games for articles designed for and essential to the operation, conduct, and playing of bingo. Any net proceeds remaining after paying prizes ... to be used in such recipient organization's charitable, civic, community, benevolent, religious, or scholastic works or similar ...
- (5) Except for instant bingo prizes,... a jackpot shall not exceed the value of \$250 in actual money or its equivalent, and there shall be no more than three jackpots in any one session of bingo.
- (6) Except for instant bingo,... the number of days per week during which organizations authorized under this section may conduct bingo shall not exceed two.
- (7) Except for instant bingo prizes,... there shall be no more than three jackpots on any one day of play. All other game prizes shall not exceed \$50.
- (8) Each person involved in the conduct of any bingo game or instant bingo must be a resident of the community where the organization is located and a bona fide member of the organization sponsoring such game and may not be compensated in any way for operation of such game. When bingo games or instant bingo is conducted by a charitable, nonprofit, or veterans' organization, the organization conducting the games must designate up to three members of that organization to be in charge of the games, one of whom shall be present during the entire session at which the games are conducted. ... A caller in a bingo game may not be a participant in that bingo game.
- (14) Any organization or other person who willfully and knowingly violates any provision of this section commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083. For a second or subsequent offense, the organization or other person commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

What that means is to restart Bingo, we need three Mainlands Four residents to be the Bingo committee to oversee the games. We also need a tracking system created to assure we are following the statute and tracking all monies collected and spent.

Are you interested in helping? If so, we can get Bingo going again!




