President's Report

Good Day! Enjoying the cold weather? It's been chilly!

We are pleased to announce we have a new Vice President! Diana Cruz has stepped up and taken the role! We are so excited for her help. We still have 2 open positions, Treasurer Receivables and Maintenance Chair. If you are interested, please let us know.

Reminder: **IF YOU RECEIVE A VIOLATION LETTER (OR COURTESY LETTER) YOU MUST RESPOND TO HER IN THE TIME GIVEN (usually 5 to 10 days depending on the violation). The time to respond is stated in the letter you receive.** Not responding is NOT an option. If no response is received, a formal violation process will commence, which may include fines and legal action. Keep in mind that the Statute allows us to fine people up to \$100 per day for a violation that is not cured.

Why do we address violations? It is not only because we want to keep our community clean and one we are proud of, which assists in property values, but the Board has a fiduciary responsibility to all homeowners to enforce our Governing Documents fairly and without favor. This means all residents are required to follow the rules and regulations, and for which you signed agreement when you attended your interview and purchased your home.

My suggestion? Walk around your house now and see if anything is out of compliance. Is there debris around the house? Have you planted without permission? Is the fascia board in need of repair or painting? Do you have plants growing higher than the window sill? Is the paint peeling or mildewed? Do you have more cars than can fit in your driveway?

These are some of the issues that we commonly see. Please correct them now before a letter or fine is needed to create compliance. Thank you.

As has been stated, we need volunteers. Some of the positions needing volunteers are New Residents Committee (interviews prospective residents), Architectural Committee (help with creating a color pallet for houses and driveways among other things), Maintenance volunteers (right now Gilles, Richard, Yvon, and Paul are helping out), and Documents Committee (we started to update and need to finish this project). Richard and Gilles are hard at work repairing the Clubhouse issues and have saved us SO much money through their volunteer repairs.

There will be a sign up sheet at the next Board and Civic meetings. Please consider helping. This is your community. It takes a village to maintain.

We have a new color palette for house and driveway colors. The Board voted to use the palette from Mainlands 3 as we consider developing another one. It can be found at the Clubhouse and on our website at mainlandssection4.org on the forms and document page.

Lastly, be sure to respond to any letters from the HOA received by mail or email. This helps resolve matters quickly and smoothly.

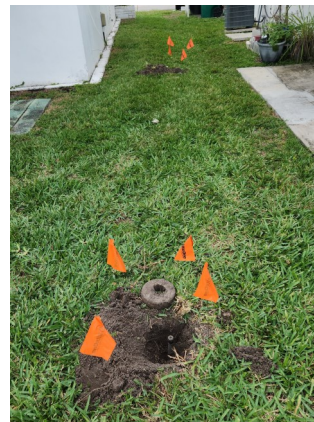

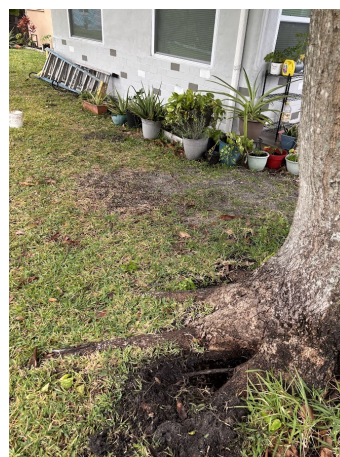
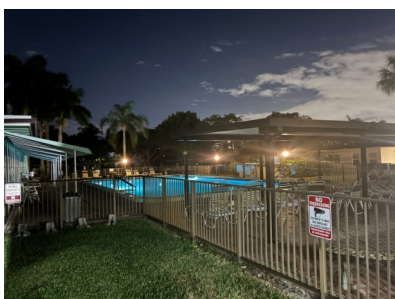
Some of the sprinkler repairs completed by Richard and Gilles, our Maintenance Volunteers.

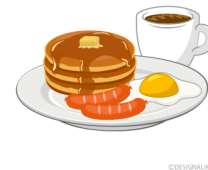
